

INFORMATION MADE TO SUPPLIERS PURSUANT TO ART. 13 OF THE EUROPEAN REGULATION N. 2016/679 (GDPR)

Purpose of the treatment. The processing of personal data is carried out for the following purposes:

1. Establishment and execution of the contractual relationship with the supplier and related activities, such as administrative and accounting activities;
2. Fulfillment of legal obligations;
3. Evaluation of suppliers;
4. Judicial protection and related activities.

Legal basis. The processing is carried out legitimately on the basis of the following conditions:

- Treatment necessary for the execution of a contract of which the interested party is a party or for the execution of pre-contractual measures adopted at the request of the same, for the purpose n. 1;
- Legal obligation, for the purpose n. 2;
- Legitimate interest, for purposes no. 3-4.

The provision of personal data is optional; however, their failure, partial and / or incorrect provision may make it impossible or inaccurate to execute the contract or pre-contractual measures.

Recipients. The personal data of the supplier may be communicated, for the purposes described, to the following categories of recipients: employees and collaborators of the Data Controller, agents, professionals (accountant, law firm, consultants), commercial information companies, agencies and public bodies, bodies and supervisory and control bodies, judicial authorities, IT service companies, consultancy companies, transport and logistics companies, credit, financial and insurance institutions.

The interested party can request the personal details of the subjects listed above from the Data Controller at any time.

Supplier data are not transferred to non-EU countries.

Duration of treatment. The treatment has a duration equal to that of the contractual relationship and the data will be kept for a maximum time of 10 years, in order to fulfill legal obligations, as well as to protect the legitimate interests of the owner.

Rights. Interested parties have the right to ask the owner for access to data concerning them, their cancellation, correction of inaccurate data, integration of incomplete data, limitation of processing, data portability, opposition to processing. in the hypothesis of legitimate interest of the owner, the withdrawal of consent in cases where the processing is based on it.

Alternatively, the interested party can send a registered letter with return receipt to the address of the Owner.

Purpose of the treatment. The processing of personal data is carried out for the following purposes:

1. Establishment and execution of the contractual relationship with the customer (fulfillment of requests and orders, sending of estimates and information material and price lists, execution of services deduced in the contract including those of a logistic nature, etc.) and related activities;
2. Fulfillment of legal obligations (eg accounting, tax, administrative, etc.);
3. Credit recovery, judicial protection and related activities;
4. Credit assessment and insurance.

Legal basis. The processing is carried out legitimately on the basis of the following conditions:
